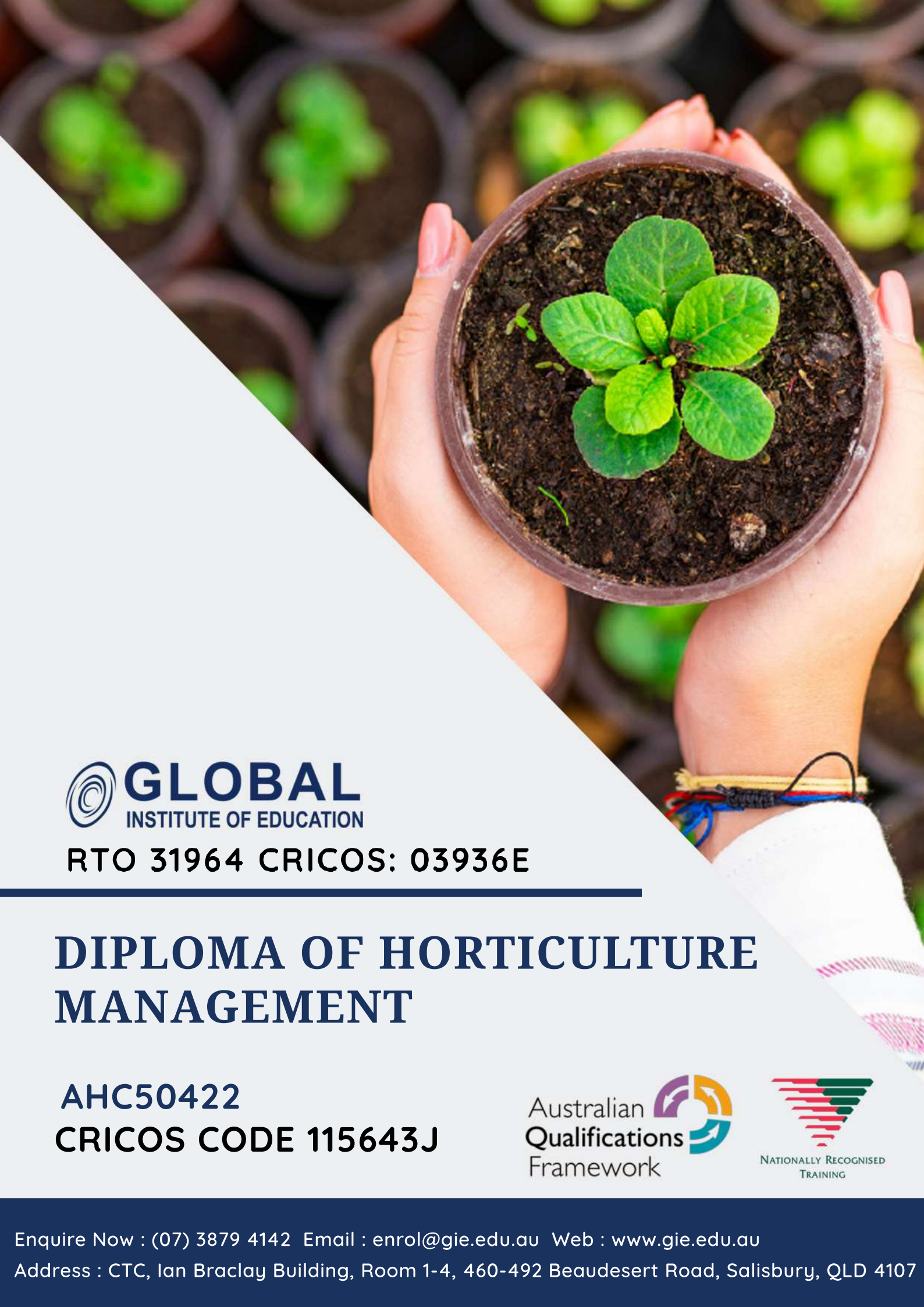

Amount of Training

The program is delivered over a period of 78 weeks. Specifically, 66 weeks of study/assessment to allow for breaks and holiday periods. Theory is delivered at our Salisbury campus and practical training would be delivered at purpose build training location. The practical training facility includes training room suited for briefings and feedback. Students must attend minimum 20 hours class time per week as part of your Student Visa requirements.

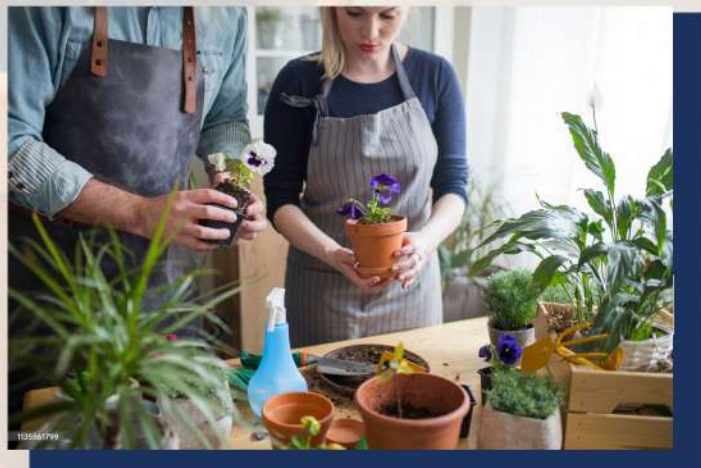
Entry Requirements

- 18 Years or over
- Basic computer skills
- Meet all student visa requirements, including IELTS 6.0, with no band less than 5.5, or equivalent on PTE, CAE or TOEFL iBT.
- Minimum Year 12 education or equivalent
- Applicants must have completed Certificate III in Horticulture or be able to demonstrate equivalent competency.

Enrolment and admission into some Global Institute of Education training programs is subject to meeting certain entry requirements. Enrollment applications will then be assessed to ensure that you meet any entry requirements that have been set for the selected course.
